- 4. The Coordinating Principal Investigator will **report** to the NT HREC **annually** and notify the NT HREC when the project is completed at all sites using the specified forms. Forms and instructions may be found on the Menzies' website.
- 5. The Coordinating Principal Investigator will notify the NT HREC if the project is **discontinued at a participating site before the expected completion date** and provide the reason/s for discontinuance.
- 6. The Coordinating Principal Investigator will notify the NT HREC of any plan to **extend the duration of the project past the approval period listed above** and will submit any associated required documentation. The preferred time and method of requesting an extension of ethical approval is during the **annual progress report**. However, an extension may be requested at any time.
- 7. The Coordinating Principal Investigator will notify the NT HREC of his or her **inability to continue as Coordinating Principal Investigator**, including the name of and contact information for a replacement.
- 8. The safe and ethical conduct of this project is entirely the responsibility of the investigators and their institution(s).
- 9. Researchers should immediately report anything which might affect continuing ethical acceptance of the project, including:
  - Adverse effects of the project on participants and the steps taken to deal with these;
  - Other unforeseen events;
  - New information that may invalidate the ethical integrity of the study; and
  - Proposed changes in the project.
- 10. Approval for a further twelve months, within the original proposed timeframe, will be granted upon receipt of an annual progress report if the NT HREC is satisfied that the conduct of the project has been consistent with the approved protocol. - 11. Confidentiality of research participants should be maintained at all times as required by law.
