- 3. Amendments to the research protocol which may affect the ongoing ethical acceptability of a protocol must be submitted to the HREC for review. - 8. The Principal Investigator will provide at least, an annual report to the HREC on the anniversary of the approval and at completion of the study in the specified format.
- 9. If you require an extension for your study, please submit a request for an extension in writing outlining the reasons. Note: One of the criteria for granting an extension is the compliance with the approval's conditions including submission of progress reports.
- 10. Any research study that prospectively assigns human participants or groups of humans to one or more health-related interventions to evaluate the effects on health outcomes (WHO / ICMJE 2008 definition) should be registered, including early phase and late phase clinical trials (phases I-III) in patients or healthy volunteers (WHO Recommendation / ICMJE policy).
